- a) Marketing Updates (John Picking, Arlene Fiorilli)
- \* The Marketing Committee reviewed the analytics from our Twitter account and it will be terminated early March. Also, the Marketing Committee recognized that Suasion has been managing Social Media for the PfH with a very limited and outdated budget. After researching value, we are prepared to allocate an appropriate amount of our budget going forward capping the monthly expenditure at \$1500/month.
